  - (d) Personnel matters involving the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee or to hear a complaint against an officer or employee. (Section 551.074, Texas Open Meetings Act)
  - (e) Water system security procedures or devices. (Section 551.076, Texas Open Meetings Act)

However, the meeting minutes will include all Public Participation Registration Forms to reflect the total number of individuals aligned on the issue.
- (e) For matters of exceptional interest to the Board, the Board may vote to extend the time allocated to one or more registered speakers and/or the total amount of time allocated for any specific agenda item.
