ORDINANCE NO. 2020-004

AN ORDINANCE OF THE BOARD OF DIRECTORS OF WYLIE NORTHEAST SPECIAL UTILITY DISTRICT OF COLLIN COUNTY, TEXAS, CANCELLING A GENERAL ELECTION ORDERED TO BE HELD ON TUESDAY, NOVEMBER 3, 2020, AND DECLARING TWO (2) UNOPPOSED CANDIDATES FOR THE OFFICE OF DIRECTOR ELECTED TO SAID OFFICE EFFECTIVE NOVEMBER 3, 2020; ADOPTING AN ORDER CANCELING THE GENERAL ELECTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of Directors of Wylie Northeast Special Utility District (the "District") ordered a General Election to be held on Tuesday, November 3, 2020, for the purpose of electing two (2) candidates to the Board of Directors of the District; and

WHEREAS, the filing deadlines for placement on the ballot and list of write-in candidates for the election have expired and, pursuant to Section 2.052, Texas Election Code, the authority responsible for having the official ballot prepared has certified in writing to the Board of Directors that candidates Ronald Dawes and Jason West are unopposed for election to the office of Director.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF WYLIE NORTHEAST SPECIAL UTILITY DISTRICT THAT:

- SECTION 1. The above findings and recitals are incorporated into the body of this Ordinance for all purposes as if fully set forth herein.
- SECTION 2. Pursuant to Section 2.053(a), Texas Election Code, candidates Ronald Dawes and Jason West have been certified as unopposed in the General Election and the Board of Directors hereby declares them elected to the office of Director. A certificate of election shall be issued to said candidates elect in the same manner and at the same time as provided for candidates elected during the General Election. The candidates elect will be administered the Oath of Office upon commencement of the first regular or special meeting of the Board of Directors held after November 3, 2020, and will thereafter exercise the duties of said office.
- SECTION 3. Pursuant to Section 2.053(b), Texas Election Code, the General Election ordered to be held on Tuesday, November 3, 2020, for the purpose of electing two (2) Directors to the Board of Directors of the District will not be held and is hereby canceled.
- SECTION 4. Pursuant to Section 2.053(a), Texas Election Code, the attached Order of Cancellation is approved and a copy of the attached Order shall be posted on election day at each polling place that would have been used in the General Election.
 - SECTION 5. This Ordinance shall take effect immediately upon and from its adoption.
